In this context, you must submit your rights mentioned in Article 11 of the Law by filling out this form, together with the information and documents that form the basis of the request, by one of the following methods.

these deficiencies are made up. In this context, the Company reserves the right to request all kinds of confirming information and documents in order to be able to identify, or to request an explanation in cases where the request is not clear.

We will finalize your request free of charge as soon as possible and within 30 (thirty) days at the latest from the date it reaches us, depending on its nature. In the event that there is an additional cost regarding the conclusion of your request, the fees in the price list determined by the Personal Data Protection Board may be requested by you. Your requests will be answered in writing to your address given below in accordance with Article 13/3 of the Law, or by sending them to your e-mail address below or to your secure e-mail address in electronic form.
